Resurfacing ofThe Hangings - a major Steam Rally event is held there annually and it's also an important emergency link route from Hughenden to Prestwood. 9. A few small sympathetically designed developments in niche sites for affordable housing for professionals, eg teachers, NHS staff etc, and also for downsizing elderly and first time buyers to enable them to remain in the area close to their neighbours and relations - in line with development guidelines in the Gt Miss Parish Village Design Statement. 10. Reserve a site in Prestwood for a future combined Infant/Junior school within the Local Plan - off Lodge Lane, also taking in the current Federation Campus School site in Nairdwood Lane if a more suitable site can be found elsewhere in the County. 11. The resulting land/buildings freed up from Junior School, Clare Road and Infant School, Moat Lane to be utilised for a mixture of housing, community use of existing school buildings, and a village centre car park with access from Pepys Drive. 12. These kids need more facilities, maybe a skate park or ramps so at least the BMX's, skateboarders and scooter riders can also get exercise while socialising.

However, I do think a regeneration or replacement of the memorial hall as a community space would be welcome, so that it works for more activities, better. It could connect better to the Buryfield grass and work as an inside/outside space, with improved access from both High Street and Link Road?  I think road safety - lighting, access for cycles and pedestrians - needs attention, whilst keeping traffic flowing. I believe treating Station Approach and the two mini roundabouts as the 'face of the village' is important. With smarter paving and a balancing of pedestrian/traffic needs, this could be improved significantly. The relatively modest smartening of the station forecourt is a good example of how this starts, but we could go much further. How we look is a big part of how we feel.  I realise there are issues to overcome, but wider pavements along the High Street would make a great deal of difference for pedestrian safety. The High Street is effectively one lane at pinch points already; if the current traffic flow could be noted and turned into a streetscape design more favourable to pedestrians and residents, that would be ideal.

Even the traffic lights in Prestwood are excessively bright and operate all night. Blue light and exposure to light at night has now been associated with diabetes, cancer, sleep problems and other chronic health problems. There is a great deal of research confirming this and two Nobel prizes were awarded last year for circadian work but awareness is almost non-existent and regulations now demand LED lights are used in most circumstances despite their harmful spectrum.

Currently pedestrian access to / from Prestwood to Gt Kingshill is cut off from the junction of Peterley Lane / Perks Lane on A4128 Wycombe Rd. Because there is no pavement on this stretch of road approx 1.5m long. The road itself has a 40mph speed limit which most drivers exceed. If there was a pavement / cycle path this would ease traffic and for residents / doing the school run, could go from one village to another without using cars and not risking their lives in the 40 mph rush if walking from one to another. Personally, I have walked this route on occasions and have been terrified facing oncoming traffic. I now have to catch a bus for that short stretch, which is not convenient with just one bus per hour. If an actual path is too costly, possibly signage for walkers and a white line delineating a walking verge would be better than the current notoriously dangerous situation.
